




Horizon 2020 Budget (2014-2020)





Spain, Italy, Greece and Bulgaria). Action Plans for renovation of pilots will be developed, identifying what energy improvement measures should implement each pilot over the next 10 years in order to be a NZEB. Following the recommendations defined in the action plans, energy improvement measures will be set up during the project duration. A roadmap will be defined with the aim of achieving NZEB in EU sport buildings in the

medium-long term. The most important barrier for sport owners is the lack of investment capital to implement full refurbishment towards NZEB. For this reason, innovative business model schemes, and in particular ESCOs will be promoted since they can finance energy improvement measures.
